




#### **BACKGROUND:**

## Factors leading to the creation of the MANSA Repository Platform









#### **High Risk Perception leading to:**

- De-risking and withdrawal of correspondent banking relationships.
- High cost of trade finance, project finance and export finance
- High cost of doing business in Africa
- Limited access to financing thus limiting competitiveness in global markets
- Low trade levels within African Counterparties







### **About The MANSA Repository Platform**

The platform derived its name from the Malian 10<sup>th</sup> Emperor, Mansa Musa who pioneered trade between Africa and the rest of the world.

The Platform is a digital central repository designed to store primary data on African Entities.

 The purpose is to provide a single source of primary data required to conduct customer due diligence checks on counterparties in Africa.







#### THE MANSA ONBOARDING PROCESS

African financial institutions, corporates and SMEs















African Financial Institutions SMEs and Corporate Entities upload their information on MANSA Repository Platform using standardized KYC/AML templates.

Information logged will be independently verified and validated by Afreximbank, in collaboration with identified partners such as regulators, recognized law firms and other government bodies.

Subscribers will be able to access due diligence information on African Corporates, SMEs and African Financial institutions upon verification of KYC Information.










Customer Due Diligence Section: Will contain Know Your Customer (KYC) information for African financial institutions, corporates and SMEs.

Invest in Africa Section: Will contain relevant information for investors and business partners seeking investment and business opportunities in Africa, such as trade information, links to investment promotion centers in Africa, etc.

News and Events Section: Will host news, events and publications which contain relevant information on customer due diligence and investing in Africa..



#### **Africa-wide Impact**

#### □ One-Stop-Shop


